A Student/Parent Center is located outside of the Counselor's Office. In it are free updated materials concerning college/career readiness, drug, tobacco & alcohol use, healthy relationships, and helping their

child prepare for life after high school in the forms of brochures, booklets, and pamphlets.

Included in the school's policy handbook the school's process for resolving parental concerns, including how to define a problem, whom to approach first, and how to develop solutions.

The principal of Nemo Vista High School has designated (1) certified staff member who is willing to serve as a parent facilitator, Chase Fresneda.

Numerous computers are available in the school lab and library where parents can access educational websites and/or access their student's grades via HAC (Parent eSchool) located on the Nemo Vista webpage.

The high school distributes a monthly parent newsletter that has insight and suggestions from parent-school organization, club sponsors, the high school office, and school staff. The newsletter will include school calendar events, club activities/announcements, school reminders/announcements, student achievement tips from the school, staff announcements, and class reminders/announcements. This newsletter will be available via hard copy in the office and on the Nemo Vista website.

The Nemo Vista website also includes teacher web pages which has assignment updates, as well as class information. Parents will also be able to use this tool for various information regarding school policy updates. Parents can access their student's grades through the eschool portal located on the homepage. At the beginning of the year they are given login information.

The school provides progress reports every fourth to fifth week in each quarter. Report cards are issued at the end of every of nine weeks. Parents will need to pay attention to the academic progress of the student. Teachers will contact parents about student progress as needed. The school will send brochures, permission slips, and various forms home with the students that the parents will need to see the school secretary, counselor, and many staff members use Remind 101 to communicate with students and parents about various due dates and school matters of importance. The Nemo Vista FB page updates announcements to keep parents informed

The radio station and newsletter will have announcements regarding important meetings or updates for parents.

 achievement goals. Parents will be asked to engage in discussion of how they can support these efforts.
 Parents will also be given suggestions for coordinating schoolparent efforts and explanations of homework
 and grading procedures.
- Two parent teacher conferences are held annually.
- An established parent/teacher organization is in place.
