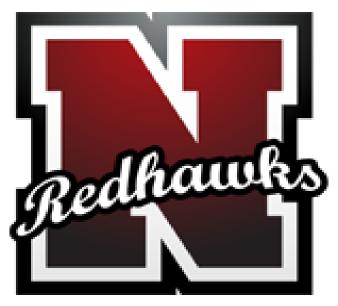

Elementary Student Goal (Grades K-5)

2023-24 Reflection:

Based on reviewing the data from actual "Discipline Referrals" in the Elementary School, overall referrals have decreased from 266 last year to 201 this school year. Not listening/following rules improved from 71 referrals to 37 referrals during the current school year (48% decrease). Students being off task/not doing work went from 72 last year to 22 this year (69% decrease). There was a slight increase in the number of disciplinary referrals this year for student to student conflict, going from 64 to 73.

After an annual administrative conference, the team determined the Elementary School Improvement Plan will indicate a continuous need to reduce the number of discipline referrals. The counselor will assist both teachers and the principal in achieving the goal of a 5% reduction of Elementary School discipline referrals by May 2025, focusing on areas of student conflict, listening/following rules and being on task/doing work.

Action Steps

- 1. Counselor will monitor all discipline referrals for the specific behaviors identified as problematic for the 2024-25 school year.
- 2. Counselor will provide classroom lessons based on the Guide for Life in the areas of listening/following rules and the importance of being on task and doing your work.
- 3. Counselor will provide classroom lessons based on the Guide for Life in the area of conflict resolution.

Middle School Student Goal (Grades 6-8)

2022-2023 Reflection:

Based on reviewing the data from actual "Discipline Referrals" in Middle School, areas of concern are still inappropriate conduct. There was an increase in the number of disciplinary referrals this year for inappropriate behaviors such as being disrespectful to both teachers and other students as well as using inappropriate language.

After an annual administrative conference, the team determined the Middle School Improvement Plan will indicate a continuous need to reduce the number of discipline referrals. The counselor will assist teachers in achieving the goal of a 5% reduction of Middle School discipline referrals by May 2024, focusing on areas of time management and listening.

Action Steps

- 1. Counselor will monitor and chart all discipline referrals for the specific behaviors identified as problematic for the 2023-24 school year.
- 2. Counselor will provide classroom lessons based on the Guide for Life in the area of appropriate behaviors and life skills.
- 3. Counselor will provide classroom lessons based on the Guide for Life which emphasize the importance of respect towards others.
- 4. Counselor will administer a pre and post-test to gauge middle school students' understanding of each lesson .
- 5. Counselor will provide individual counseling in those areas for students with multiple referrals/repeated offenses.

High School Student Goal (Grades 9-12)

2022-23 Reflection:

After reviewing individual Disciplinary Referrals for the 2022-23 school year, the overall number of referrals increased from the previous year. However, the main areas of concern are still excessive tardiness and misuse of technology (including using cell phones without permission). Out of the 146 total referrals, 26% of those were for misuse of technology and 17% of all referrals issued for excessive tardiness. Most offenses only resulted in warnings or lunch detention.

2023-24 Student Goal: After an annual administrative conference, the team determined the counselor will support the teachers in reducing the number of high school student discipline referrals by 5% for the 2023-24 school year as stated in the school improvement plan.

Action Steps:

- 1. Counselor will provide Advisory teachers a calendar based on the GUIDE for Life curriculum (Advisory is scheduled daily from 11:32-11:58). This calendar will help assist Advisory teachers with materials and lessons emphasizing the importance of goal setting and progress monitoring (keeping up with their attendance and grades).
- 2. Counselor may provide one on one interventions to students with repeat offenses in the deficit areas.
- Counselor will meet with students by grade level (9th-12th) on a monthly basis in order to implement strategies to improve their overall mental health, help them become college and career ready (SSPs), as well as provide them with information to reinforce the importance of proper cell phone use, setting goals, and time management.

Program Management/Manage

A Nemo Vista Comprehensive Counseling program self- assessment was completed. Counselors requested a copy of the Arkansas Comprehensive School Counseling Self-Assessment via email and used the rubric to identify areas of concern in the program that need to be addressed.

Advisory Council

Nemo Vista School District has a super committee advisory team in place to provide feedback to the district, review programs, and make recommendations about areas of need. Advisory teams including the school nurse, building principals, counselors, teachers, and mental health professionals (professional counselors from The Pointe and Counseling Associates and mobile assessors) meet when determining the mental health status of a student for professional counseling, suicide prevention, and/or student referrals.

Calendars

Nemo Vista School Counselors use calendars, schedules, and other assessment tools based on the ASCA National Model and Guide for Life to ensure the recommended 90 percent of the school counselor's time is dedicated towards direct and indirect services with students.

The ASCA School Counselor Professional Standards & Competencies address the academic achievement, career planning and social/emotional development of students. The <u>ASCA Ethical Standards</u> guide school counselors in maintaining the highest standard of integrity, leadership, and professionalism.

Delivery/Deliver

Nemo Vista counselors provide Direct Counseling Services to students.

School counselors provide individual and group counseling to all students. Services are described below and are reviewed and updated annually.

Classroom lessons are age-appropriate, collaborative efforts with teachers to use the information presented to reinforce goals for students in the areas of academic, social/emotional and career development, and support the school improvement plan. Lessons are no more than 40 minutes per session and no more than 3 sessions per day and 10 sessions per week.

Bullying

Nemo Vista School Counselors follow the district policy and procedure for reporting bullying behavior.

Nemo Vista Counselors work with students through lessons and interventions to help them understand what a bystander is and encourage them to report any instance of bullying they witness to a trusted adult.

Nemo Vista Counselors along with other teachers and staff are required by DESE to earn two hours of bullying prevention professional development every two years.

Bullying Procedure (taken from the NV School District Section 2 Handbook)

Students are encouraged to report behavior they consider to be bullying; including a single action which if allowed continuing would constitute bullying, to their teacher or the building principal. The report may be made anonymously. Teachers and other school employees who have witnessed, or are reliably informed that, a student has been a victim of behavior they consider to be bullying, including a single action which if allowed to continue would constitute bullying, shall report the incident(s) to the building principal, designee, as soon as possible. Parents or legal guardians may submit written reports of incidents they feel constitute bullying, or if allowed to continue would be bullying, to the building principal or designee. **The person or persons reporting behavior they consider to be bullying shall not be subject to retaliation or reprisal in any form.**

A building principal, or designee, who receives a credible report or complaint of bullying shall:

- 1. As soon as reasonably practicable, but by no later than the end of the school day following the receipt of the credible report of bullying: a. Report to a parent, legal guardian, person having lawful control of a student, or person standing in loco parentis of a student that their student is the victim in a credible report of bullying; and b. Prepare a written report of the alleged incident of bullying;
- 2. Promptly investigate the credible report of complaint of bullying, which shall be completed by no later than the fifth (5th) days following the completion of the written report.
- 3. Notify within five (5) days following the completion of the investigation the parent, legal guardian, person having lawful control of a student, or person standing in loco parentis of a student who was the alleged victim in a credible report of bullying whether the investigation found the credible report or complaint of bullying to be true and the **availability of counseling and other intervention services.**
- 4. Notify within five (5) days following the completion of the investigation the parent, legal guardian, person having lawful control of the student, or person acting in loco parentis of the student who is alleged to have been

the perpetrator of the incident of bullying: a. That a credible report or complaint of bullying against their student exists; b. Whether the investigation found the credible report of complaint of bullying to be true; c. Whether action was taken against their student upon the conclusion of the investigation of the alleged incident of bullying; and d. Information regarding the reporting of another alleged incident of bullying, including potential consequences of continued incidents of bullying;

5. Make a written record of the investigation, which shall include; a. A detailed description of the alleged incident of bullying, including without limitation a detailed summary of the statements from all material witnesses to the alleged incident of bullying b. Any action taken as a result of the investigation; and

6. Discuss, as appropriate, the availability of counseling and other intervention services with students involved in the incident of bullying.

Students found to be in violation of this policy shall be subject to disciplinary action up to and including expulsion. In determining the appropriate disciplinary action, consideration may be given to other violations of the student handbook which may have simultaneously occurred. In addition to any disciplinary actions, the District shall take appropriate steps to remedy the effects resulting from bullying. Notice of what constitutes bullying, the District prohibition against bullying, and the consequences for students who bully shall be conspicuously posted in every classroom, cafeteria, restroom, gymnasium, auditorium, and school bus. Parents, legal guardians, persons having lawful control of a student, persons standing in loco parentis, students, school volunteers, and employees shall be given copies of the notice annually. The superintendent shall make a report annually to the Board of Directors on student discipline data, which shall include, without limitation, the number of incidents of bullying reported and the actions taken regarding the reported incidents of bullying.

Level of consequences will be at the administrator's discretion. Levels of Consequences: Level A: (Minimum): Student –Principal Conference (warning) Level B: Detention 82 Level C: Student, Parent, Principal Conference Level D: In-school Suspension Level E: Corporal Punishment Level F: Suspension Level G: (Maximum): Expulsion Students or adults, who knowingly fabricate allegations and falsely accuse a student of being a bully, will be subject to disciplinary action. Copies of this policy shall be available upon request. 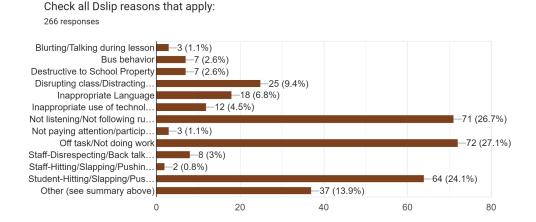
In order to demonstrate the effectiveness of the school counseling program in measurable terms, school counselors analyze school and school counseling program data to determine student need. School counselors use data to show the impact of the school counseling program on student achievement, attendance and behavior and analyze school counseling program assessments to guide future actions and improvements. The performance of the school counseling program is evaluated on the implementation of the mindsets and behaviors that guide a comprehensive school counseling program. School counselors incorporate organizational assessments and tools that are concrete, clearly delineated and reflective of the school's needs.

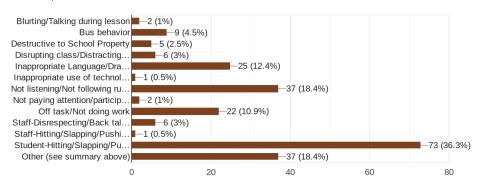

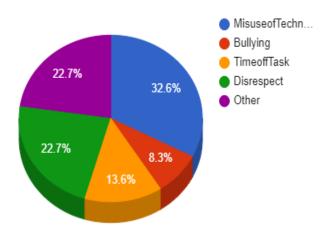

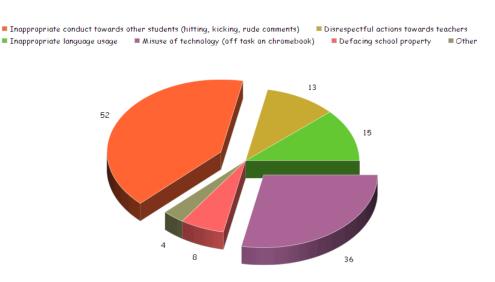


Middle School









Program Results

Elementary

Current discipline data for the elementary school shows a continued need for interventions dealing with not listening/not following directions, being off task/not doing work and student conflict. Analysis of discipline referrals for the two school years allows us to see that the total number of discipline referrals decreased from year 2022/2023 to 2023/2024, however the percentage for student conflict rose slightly. The counselor will provide interventions and classroom lessons based on the GUIDE For Life curriculum addressing these needs.

Analysis of data shows that 7 out of 10 students that struggled with being off task/not doing work or not listening/not following directions during the 2023/2024 school year improved, either receiving 0 or only 1-2 more discipline slips, after receiving individual interventions. These interventions will continue to be used on an individual basis next school year.

Middle School

Current discipline data for middle school shows a much higher need for interventions dealing with students' inappropriate conduct versus the misuse of technology from the previous year. Analysis of discipline referrals for the two school years allows us to see that individual interventions, guest speakers, and classroom lessons based on the GUIDE For Life curriculum provided by the counselor during the 2021-22 school year did make a positive impact in students' overall misuse of technology.

After reviewing perception data results, teachers in middle school do not think that the classroom lessons provided enough support in the areas of respect and goal setting. This assessment is accurate after reviewing the high number of discipline referrals for student misconduct and not completing work on time or at all. The counselor will provide better support to teachers in these areas for the 2022-23 school year. The counselor will work closely with the dean of students to

identify such referrals early and provide individual and/or small group intervention to those students.

High School

Discipline data for the 2021-22 school year show a continued need for intervention in the areas of study accountability/tardiness. Advisory lessons in this area were presented to teachers but not effective in reducing the amount of students who were late to class. Repeat offenders were provided individual counseling in the areas of time management and goal setting, but also didn't prove to be effective. For the upcoming 2022-23 school year, the focus for the program will remain supporting teachers and administration in *motivating* students to have better attendance, but to be in class on time and the importance of time management in meeting their college/career goals.

Evaluation and Improvement

Goals and results are evaluated and updated annually in the Nemo Vista School District Comprehensive Counseling Plan. Evaluation results are shared with stakeholders in a variety of ways.
